## 4. DEPOSITS AND WITHDRAWALS

### 4.1 DEPOSIT METHODS

Prime Ten accepts deposits through the following payment methods

- Bitcoin
- TRON
- Ripple (XRP)
- Tether (USDT)
- Binance Coin (BNB)
- Litecoin (LTC)
- Dogecoin (DOGE)

Deposits are processed immediately or within a few minutes, depending on the blockchain network conditions. You are responsible for ensuring that the deposit is made using the correct payment method

### 4.2 WITHDRAWAL METHODS

Withdrawals can be made only via USDT TRC-20 and USDT BEP-20.

Requests will be processed within 0-4 hours after submission, depending on network conditions.

### 4.3 MINIMUM WITHDRAWAL AMOUNT

The minimum withdrawal amount is \$10. Any request below this amount will not be processed.

### 4.4 WITHDRAWAL FEES

- Withdrawal Charges: A 10% fee is applicable for ROI & Commission withdrawals.
- External Transfer Charges: A 2% fee is applicable for external transfers.
- Internal Transfers: There are no charges for internal transfers between Prime Ten accounts.

## 5. BONUSES AND REWARDS

### 5.1 BONUS PROGRAMS
